## LEGISLATIVE SESSION REPORT — FEBRUARY 25, 2022

With two weeks left in the Legislative Session, we are in the “End Game” on several issues:

**Medical Specialty Designation Bill (HB 861):** Just passed the House and is in Messages to the Senate. Senate likely will not take it up, but it remains available as “trade bait” during the last two weeks of Session.

**Telehealth (SB 312):** Different versions have passed both the House and Senate, both of which allow for telehealth prescribing of Schedules III-V. The only issue is whether “telephone-only” constitutes telehealth (House says it should not). The bill is now in Messages in the Senate. We would be surprised if a resolution is not reached in the last two weeks.

**PBMs (HB 357/SB1476):** The House Bill is now up for final passage today, and the Senate Bill has its last committee stop on Monday. The bill places PBMs under the jurisdiction of the Office of Insurance Regulation and requires some transparency, but it is only a first step.

**Step Therapy (HB 459/SB 730):** The House Bill has advanced to Third (i.e., final) Reading, and the Senate Bill is on the floor. The bill facilitates overrides of Step Therapy, but does not limit Step Therapy protocols.

**Physician Free Speech: (HB 687/SB 1184)** The House Bill is in the House Health and Human Services Committee, which is scheduled to meet one last time on Monday. The Senate Bill is still in Appropriations, but it is not on Monday’s agenda, which currently would be its last opportunity under the current schedule. Something extraordinary would have to happen for this to pass.

**What Has Already Been Passed:** Covid Liability Protection for Physicians (SB 7014). Governor Desantis signed the bill last night!

**What Has Already Been Defeated:** APRN and PA Scope of Practice Expansion, Restrictions on Physician Mergers, Additional Physician Disclosures.

**Threats Still Remaining:** Wrongful Death Actions Against Physicians. A bill to allow such actions by adult children of victims passed the House Judiciary Committee this week and is scheduled for House debate next week, but has seen no movement yet in the Senate.
